Permission to use Agreement

Subject to the following conditions, I/we request permission to reproduce images from the Abraham Lincoln Presidential Library & Museum:

Conditions

1. Credit must be given for each item used. Credit Line is: Abraham Lincoln Presidential Library & Museum (ALPLM). Use fees must be paid in advance of receiving use permissions and are non-refundable. Use fees are subject to change without notice.
2. Permission is granted for one-time use only, and a use fee is charged for each item. Fees are listed on the next form. Written permission and use fees are required again for each additional use, revised edition, paperback edition, etc.
3. Copies obtained from the ALPLM may not be deposited in another repository.
4. The ALPLM does not claim copyright of all materials in its collections. The user assumes all responsibility for securing reproduction rights and for any infringement of the U.S. Copyright Code.
5. In granting permission for use, the ALPLM does not surrender its right thereafter to use any of the materials from its collection or to grant other permission to use.
6. The ALPLM does not grant an exclusive right to use any of its material.
7.
